NOTICE IS HEREBY GIVEN that the Leicestershire County Council intends not less than 7 days from the date of this Notice to make an Order under Section 14(1) of the Road Traffic Act 1984. It is expected that the Order will come into force on 22<sup>ND</sup> August 2022 and have a maximum duration of 18 months. The works will be completed within the period of the Order. The works will commence when the appropriate signs are erected and may last for up to 8 weeks. The Temporary Traffic Regulation Order is being enforced for public safety to allow Leicestershire County Council undertake carriageway resurfacing works and any other various Utility and highway maintenance works. The proposed various diversion routes will be signed on site. During the closures, alternative diversion routes available to traffic will be signed on site.

**SCHEDULE 1**

**TEMPORARY PROHIBITION OF ALL THROUGH TRAFFIC**

**A607 Newark Road / A607 Syston bypass** – in both directions from the junction of Humberstone Lane to A46 Hobby Horse roundabout.

**Melton Road** – from its junction with A607 Asda roundabout to Britannia Way.

**Barkby Thorpe Lane** – from its junction with A607 to the access at Asda

**Melton Road** – from its junction with A607 Asda roundabout to Westmoreland Avenue.

**Pontylue Way** – closed between A607 Syston bypass and Raynes Way.

**SCHEDULE 2**

**TEMPORARY PROHIBITION OF WAITING AT ANY TIME**

**Melton Road** – on both sides of the carriageway, from its junction with A607 Asda roundabout to Britannia Way.

**SCHEDULE 3**

**TEMPORARY PROHIBITION OF LOADING AT ANY TIME**

**Melton Road** – on both sides of the carriageway, from its junction with A607 Asda roundabout to Britannia Way.

**SCHEDULE 4**

**TEMPORARY IMPOSITION OF 30MPH SPEED RESTRICTION**

**A607 Newark Road** - North Bound and South Bound between the junction of Checkland Road and the junction of Pontylue Way

**SCHEDULE 5**

**TEMPORARY SUSPENSION OF 7.5 TONNE WEIGHT RESTRICTION**

**Church Hill Road** – between Earls Way and Silverdale Drive.

**Silverdale Drive** – between Church Hill Road and Humberstone Lane.

**Humberstone Lane** – between Silverdale Drive and A607 Newark Road.
